Dear Digestive Health Patient,

Prior to proceeding you must complete a telephone health history interview with one of our nurses and verify the scheduling of your procedure with our staff, who will also verify that your “colon cleanse” prescription has been forwarded to your pharmacy. These steps, and your completion of these forms at home, eliminate the inconvenience and the added cost of a separate pre-procedure office visit.

If there are issues you wish to discuss you should call us to schedule a separate office appointment.

AUTHORIZATION AND CONSENT FOR ENDOSCOPIC PROCEDURES,
PHYSICIAN/PATIENT DISCLOSURE and CONDITIONS OF ADMISSION

CONSENT TO ADMISSION AND PROCEDURE: Your physician has recommended that you undergo an endoscopic procedure. This procedure, together with any different or additional procedures, which in the opinion of your physician may be indicated due to any emergency, will be performed on you by your physician, together with associates and assistants to whom the supervising physician may assign designated responsibilities. If he or she has not already done so, your physician will obtain your informed consent to treatment for the procedure you will undergo.

INDEPENDENT CONTRACTORS: The persons who perform specialized medical services such as pathology are not agents or employees of the Center or your supervising physician. They are independent contractors and the Center is not responsible or liable for their acts or omissions.

TISSUE DISPOSAL: *I authorize the pathologist to use his discretion in disposing of any tissue removed from your person during the operation or procedure set forth above.*

RELEASE OF INFORMATION TO CORI FOR RESEARCH PURPOSES: Digestive Health is a member of the CORI (www.cori.org) research consortium. CORI is a nonprofit research subsidiary of the American Society for Gastrointestinal Endoscopy which is housed at the University of Oregon Health Sciences Center in Portland. We use information about your procedure to better understand and improve clinical practice here in Durango, and we share deidentified data (information from which all government-specified personal identifying characteristics has been removed) with CORI, which maintains the National Endoscopy Database. The information released to CORI contains only general information about your procedure. No personal identifying information (such as name, address, or social security number) is sent to CORI. *I authorize the release of deidentified information about my procedure via the internet to the Clinical Outcomes Research Initiative.*

LEGAL RELATIONSHIP BETWEEN FACILITY AND PHYSICIAN: I acknowledge that I have been informed that the Southwest Endoscopy Center (Center) is owned by a Limited Liability Limited Partnership, which in turn is owned by Drs. Patrick D. Gerstenberger, Steven R. Christensen, and Stuart B. Saslow. The Center is disclosing a financial relationship with the physician performing your procedure.

RELEASE OF INFORMATION: *I agree that the Center may disclose information on me, including my medical records, to any third-party payors, including, but not limited to, health insurers, health care service plans, welfare agencies, worker's compensation carriers, or my employer as provided for in its Policy of Privacy Practices. My record may also be disclosed to other health care providers as necessary for my health care.*

FINANCIAL AGREEMENT: *I agree to pay the Center in accordance with its regular rates and terms. Should my account be referred to an attorney for collection, I shall pay the Center's reasonable attorney's fees and collection expenses. I shall also pay interest at the legal rate on my unpaid balance.* If you do not have insurance coverage, it is our policy to collect payment in full prior to or at the time of service. SEC can offer a 20% discount on your bill if you do not have insurance and if you pay in full at the time of service. If you do have insurance coverage, we will prepare a claim and send it to your insurance company for you. In the event that your insurance plan determines a service to be "not covered," you will be responsible for the charges. A schedule of typical fees for services provided in the Center is available for review upon request.

PATIENT BILL OF RIGHTS

Digestive Health Associates and the Southwest Endoscopy Center have adopted and affirm as policy the following rights of patient/clients who receive services from our facility.

This policy affords you, our patient, the right to:

1. Treatment without discrimination as to race, color, religion, sex, national origin, political belief, or handicap. It is our intention to treat each patient as a unique individual in a manner that recognizes their basic human rights.
2. Considerate and respectful care including consideration of psychosocial, spiritual, and cultural variables that influence the perceptions of illness.
3. Receive, upon request, the names, professional status, and experience of all personnel participating in your care.
4. Obtain from the person responsible for your health care complete and current information concerning your diagnosis, treatment, and expected outlook in terms you can be reasonably expected to understand. When it is not medically advisable to give such information to you, the information shall be made available to an appropriate person in your behalf.
5. Receive information necessary to give informed consent prior to the start of any procedure and/or treatment, except in emergency situations. This information shall include as a minimum an explanation of the specific procedure or treatment itself, its value and significant risks, and an explanation of other appropriate treatment methods, if any.
6. The patient may elect to refuse treatment. In this event, the patient must be informed of the medical consequences of this action. In the case of a patient who is mentally incapable of making a rational decision, approval will be obtained from the guardian, next-of-kin, or other person legally entitled to give such approval. The Facility will make every effort to inform the patient of alternative facilities for treatment if we are unable to provide the necessary treatment.
7. Upon request, the facility will assist you in formulating advance directives and appointing a surrogate to make health care decisions on your behalf, to the extent permitted by law. Access to health care at this facility will not be conditioned upon the existence of an advance directive.
8. Privacy to the extent consistent with adequate medical care. Case discussions, consultation, examination and treatment are confidential and should be conducted discreetly.
9. Privacy and confidentiality of all records pertaining to your treatment, except as otherwise provided by law or third party payment contract.
10. A reasonable response to your request for services customarily rendered by the facility, and consistent with your treatment.
11. Expect reasonable continuity of care and to be informed, by the person responsible for your health care, of possible continuing health care requirements following discharge, if any.
12. Refuse to participate in research. Human experimentation affecting care or treatment shall be performed only with your informed consent.
13. Upon request, examine and receive a detailed explanation of your bill including an itemized bill for services received, regardless of sources of payment.
14. Know the facility's rules and regulations that apply to your conduct as a patient.
15. Any unanswered concerns on the part of patients or family relative to ethical issues can, with sufficient notice, be referred to our Continuous Quality Improvement Committee for advice.
16. Complaints or criticisms will not compromise future access to care at this facility. Our staff will gladly advise you of the procedure for registering a complaint/grievance.

FINANCIAL POLICY

To reduce confusion and misunderstanding between our patients and these practices, we have adopted this financial policy. If you have any questions, please do not hesitate to discuss them with our facility administrator. We are dedicated to providing the best possible care and service to you, and we regard the understanding of your financial responsibilities as an essential element of your care and treatment.

PRIMARY INSURANCE

We currently have direct arrangements with several insurance companies, including Anthem Blue Cross and Blue Shield, HMO Colorado, Rocky Mountain Health Plans, Medicare and Colorado Medicaid, to accept their allowed amount. We will bill these plans directly, and will require you to pay only the authorized co-payment and deductible. **It is the policy of this office to collect the co-payment at the time of service.**

We anticipate periodic additions and deletions to our list of contracted plans. Please contact our office or check our web site (www.digestivehealth.net) for current information regarding our participation status.

If you have insurance coverage through a plan with which we do not currently participate, we will collect from you any amounts not paid by your insurance. We will prepare and send your insurance company a claim. The insurance company may send the payment to you or to us. If it is sent to you, full payment on your account balance must be made immediately on receipt of the insurance check. In the event your health plan determines a service to be "not covered," you will be responsible for the complete charge.

If your insurance requires a referral from a primary care provider, it is your responsibility to obtain one.

SECONDARY INSURANCE

Our office will submit secondary insurance claims for you.

DISCOUNTS

If you do not have insurance coverage, we can offer you a 20% discount on your bill if you pay in full at the time of service.

SELF PAY

If you do not have insurance coverage, it is our policy to collect payment in full at the time of service. Any payment arrangements must be approved by the billing department. We may charge interest on past due accounts.

LATE CANCELLATION FEES

Digestive Health Associates charges a fee for visits or procedures that are not cancelled within 24 hours of the scheduled appointment. The fees are: \$25 for an office visit, and \$100 for a procedure (at either Southwest Endoscopy Center or Mercy Regional Medical Center).

LATE PAYMENT FEES

SCOPE OF PRACTICE NOTICE

In order for us to provide you with the best care we can, it is important for you to understand our role as specialists. Our practice is limited to **gastroenterology** (diagnosis and treatment of disorders of the esophagus, stomach, intestines and pancreas), **hepatology** (diagnosis and treatment of liver disorders), and **gastrointestinal endoscopy**. Our scope is limited to the evaluation and management of the specific problem for which we are seeing you.

If we are seeing you at your physician's or providers request we will forward a written report of our findings and recommendations. We may order or perform diagnostic tests, such as endoscopy or x-ray studies, and may write prescriptions for treatments that we recommend. You may obtain the results of tests that we order or perform directly from this office. While we may assume responsibility for a portion of your care, in no instance will we be able to provide for your overall health care needs. **Your primary care physician or provider remains in charge of your case.**

If we are seeing you without referral from another physician or provider we may order or perform diagnostic tests, such as endoscopy or x-ray studies, and may write prescriptions for treatments that we recommend. We may assume responsibility for the ongoing management of a portion of your overall care limited to the gastrointestinal problem for which we are seeing you. In no instance will we be able to provide for your overall health care needs. **We strongly urge our patients to have a primary care physician or provider**

As gastroenterologists, we do not provide basic health care. Routine physical examinations, pelvic examinations and pap smears, breast examinations and cholesterol or cancer screening tests are the responsibility of your primary care physician.

I have read and understand the above statement. I agree to accept these limitations of duty in my care. I am aware that the practice of medicine and surgery is not an exact science and I acknowledge that no guarantees have been made to me as to results of treatments, tests or examination.

NOTICE OF PRIVACY PRACTICES

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY.

WHO WILL FOLLOW THIS NOTICE

This notice describes our practice and that of:

- Any health care professional authorized to enter information into your office chart;
- All departments and units of this office practice;
- Any member of a volunteer group we allow to help you while you are in the office;
- Any medical student, intern, resident or fellow that we allow to help you while you are in the office;
- Any representative of an insurance carrier, managed care organization, clinical research organization, data analysis organization, or quality improvement organization that is participating in a review of your medical care;
- All employees, staff and other office personnel; and,
- All other entities, sites and locations where the health care professionals in this office practice and follow the terms of this notice. In addition, these entities, sites and locations may share medical information with each other for treatment, payment or operations purposes as described in this notice.

OUR PLEDGE REGARDING MEDICAL INFORMATION

We understand that medical information about you and your health is personal. We are committed to protecting medical information about you. We create a record of the care and services you receive at this office. We need this record to provide you with quality care and to comply with certain legal requirements. This notice applies to all of the records of your care generated by the office, whether made by office personnel or your personal doctor. This notice will tell you about the ways in which we may use and disclose medical information about you. We also describe your rights and certain obligations we have regarding the use and disclosure of medical information.

We are required by law to:

- make sure that medical information that identifies you is kept private;
- give you this notice of our legal duties and privacy practices with respect to medical information about you; and follow the terms of the notice that is currently in effect.

HOW WE MAY USE AND DISCLOSE MEDICAL INFORMATION ABOUT YOU

The following categories describe different ways that we use and disclose medical information. For each category of uses or disclosures we will explain what we mean and try to give some examples. Not every use or disclosure in a category will be listed. However, all of the ways we are permitted to use and disclose information will fall within one of the categories.

Treatment - We may use medical information about you to provide you with medical treatment or services. We may disclose medical information about you to doctors, nurses, technicians, medical students, or other office personnel who are involved in taking care of you at the office. For example, a doctor treating you for an intestinal condition may need to know if you have diabetes because diabetes may affect the management of your intestinal problem. In addition, the doctor may need to tell the dietitian if you have diabetes so that we can arrange for you to receive information regarding appropriate meals. Different departments of the office also may share medical information about you in order to coordinate the different things you need, such as prescriptions, lab work, endoscopy examinations and x-rays. We also may disclose medical information about you to people outside the office who may be involved in your medical care after you leave the office, such as your primary care physician/provider, other medical consultants, family members, clergy or others we use to provide services that are part of your care.

Payment - We may use and disclose medical information about you so that the treatment and services you receive at the office, hospital, endoscopy center, nursing home or other site may be billed to and payment may be collected from you, an insurance company or a third party. For example, we may need to give your health plan information about the services you received at the office, hospital or endoscopy center, so that your health plan will pay us or reimburse you for the services. We may also tell your health plan about a treatment you are going to receive to obtain prior approval or to determine whether your plan will cover the treatment.

Health Care Operations - We may use and disclose medical information about you for office operations. These uses and disclosures are necessary to operate the office and make sure that all of our patients receive quality care. For example, we may use medical information to review our treatment and services and to evaluate the performance of our staff in caring for you. We may also combine medical information about many office patients to decide what additional services the office should offer, what services are not needed, and whether certain new treatments are effective. We may also disclose information to doctors, nurses, technicians, medical students, and other office personnel for review and learning purposes. We may also combine the medical information we have with medical information from other offices to compare how we are doing and see where we can make improvements in the care and services that we offer. We may remove information that identifies you from this set of medical information so others may use it to study health care and health care delivery without learning who the specific patients are.

Appointment Reminders - We may use and disclose medical information to contact you as a reminder that you have an appointment for treatment or medical care at the office or endoscopy center.

Treatment Alternatives - We may use and disclose medical information to tell you about or recommend possible treatment options or alternatives that may be of interest to you.

Health-Related Benefits and Services - We may use and disclose medical information to tell you about health-related benefits or services that may be of interest to you.

Endoscopy Center Directory - We may include certain limited information about you in the endoscopy center directory while you are a patient at the Southwest Endoscopy Center. This information may include your name, location in the endoscopy center, and your general condition (e.g., fair, stable, etc.) This is so your family and friends can visit you in the endoscopy center and generally know how you are doing.

Individuals Involved in Your Care or Payment for Your Care - We may release medical information about you to a friend or family member who is involved in your medical care. We may also give information to someone who helps pay for your care. We may also tell your family or friends your condition and that you are in the hospital, endoscopy center or office. In addition, we may disclose medical information about you to an entity assisting in a disaster relief effort so that your family can be notified about your condition, status and location.

Research - Under certain circumstances, we may use and disclose medical information about you for research purposes. For example, a research project may involve comparing the health and recovery of all patients who received one medication to those who received another, for the same condition. All research projects, however, are subject to a special approval process. This process evaluates a proposed research project and its use of medical information, trying to balance the research needs with patients' need for privacy of their medical information. Before we use or disclose medical information for research, the project will have been approved through this research approval process. We may, however, disclose medical information about you to people preparing to conduct a research project, for example, to help them look for patients with specific medical needs, so long as the medical information they review does not leave the office. We will almost always ask for your specific permission if the researcher will have access to your name, address or other information that reveals who you are, or will be involved in your care at the office.

As Required By Law - We will disclose medical information about you when required to do so by federal, state or local law.

To Avert a Serious Threat to Health or Safety - We may use and disclose medical information about you when necessary to prevent a serious threat to your health and safety or the health and safety of the public or another person. Any disclosure, however, would only be to someone able to help prevent the threat.

SPECIAL SITUATIONS

Organ and Tissue Donation - If you are an organ donor, we may release medical information to organizations that handle organ procurement or organ, eye or tissue transplantation or to an organ donation bank, as necessary to facilitate organ or tissue donation and transplantation.

Military and Veterans - If you are a member of the armed forces, we may release medical information about you as required by military command authorities. We may also release medical information about foreign military personnel to the appropriate foreign military authority. If you are a member of the Armed Forces, we may disclose medical information about you to the Department of Veterans Affairs upon your separation or discharge from military services. This disclosure is necessary for the Department of Veterans Affairs to determine whether you are eligible for certain benefits.

Workers' Compensation - We may release medical information about you for workers' compensation or similar programs. These programs provide benefits for work-related injuries or illness.

Public Health Risks - We may disclose medical information about you for public health activities. These activities generally include the following:

- To prevent or control disease, injury or disability;
- To report births and deaths;
- To report child abuse or neglect;
- To report reactions to medications or problems with products;
- To notify people of recalls of products they may be using;
- To notify a person who may have been exposed to a disease or may be at risk for contracting or spreading a disease or condition; and,
- To notify the appropriate government authority if we believe a patient has been the victim of abuse, neglect or domestic violence. We will only make this disclosure if you agree or when required or authorized by law.

Health Oversight Activities - We may disclose medical information to a health oversight agency for activities authorized by law. These oversight activities include, for example, audits, investigations, inspections, and licensure. These activities are necessary for the government to monitor the health care system, government programs, and compliance with civil rights laws.

Lawsuits and Disputes - If you are involved in a lawsuit or a dispute, we may disclose medical information about you in response to a court or administrative order. We may also disclose medical information about you in response to a subpoena, discovery request, or other lawful process by someone else involved in the dispute, but only if efforts have been made to tell you about the request or to obtain an order protecting the information requested.

Law Enforcement - We may release medical information if asked to do so by a law-enforcement official:

- In response to a court order, subpoena, warrant, summons or similar process;
- To identify or locate a suspect, fugitive, material witness, or missing person;
- About the victim of a crime if, under certain limited circumstances, we are unable to obtain the person's agreement;
- About a death we believe may be the result of criminal conduct;
- About criminal conduct at the office or ambulatory surgery center; and
- In emergency circumstances to report a crime; the location of the crime or victims; or the identity, description or location of the person who committed the crime.

Coroners, Medical Examiners and Funeral Directors - We may release medical information to a coroner or medical examiner. This may be necessary, for example, to identify a deceased person or determine the cause of death. We may also release medical information about patients to funeral directors as necessary to carry out their duties.

National Security and Intelligence Activities - We may release medical information about you to authorized federal officials for intelligence, counterintelligence, and other national security activities authorized by law.

Protective Services for the President and Others - We may disclose medical information about you to authorized federal officials so they may provide protection to the President, other authorized persons or foreign heads of state or conduct special investigations.

Department of State - We may use medical information about you to make decisions regarding your medical suitability for a security clearance or service abroad. We may also release your medical suitability determination to the officials in the Department of State who need access to that information for these purposes.

Inmates - If you are an inmate of a correctional institution or under the custody of a law enforcement official, we may release medical information about you to the correctional institution or law enforcement official. This release would be necessary (1) for the institution to provide you with health care; (2) to protect your health and safety or the health and safety of others; or (3) for the safety and security of the correctional institution.

YOUR RIGHTS REGARDING MEDICAL INFORMATION ABOUT YOU

You have the following rights regarding medical information we maintain about you:

Right to Inspect and Copy - You have the right to inspect and copy medical information that may be used to make decisions about your care. Usually, this includes medical and billing records, but does not include psychotherapy notes. To inspect and copy medical information that may be used to make decisions about you, you must submit your request in writing to the facility administrator. If you request a copy of the information, we may charge a fee as permitted by state law for the costs of copying, mailing or other supplies associated with your request.

We may deny your request to inspect and copy in certain very limited circumstances. If you are denied access to medical information, you may request that the denial be reviewed. Another licensed health care professional chosen by the office will review your request and the denial. The person conducting the review will not be the person who denied your request. We will comply with the outcome of the review.

Right to Amend - If you feel that medical information we have about you is incorrect or incomplete; you may ask us to amend the information. You have the right to request an amendment for as long as the information is kept by or for the office. To request an amendment, your request must be made in writing and submitted to the facility administrator. In addition, you must provide a reason that supports your request. We may deny your request for an amendment if it is not in writing or does not include a reason to support the request. In addition, we may deny your request if you ask us to amend information that:

- Was not created by us, unless the person or entity that created the information is no longer available to make the amendment;
- Is not part of the medical information kept by or for the office;
- Is not part of the information which you would be permitted to inspect and copy; or,
- Is accurate and complete.

Right to an Accounting of Disclosures - You have the right to request an "accounting of disclosures." This is a list of the disclosures we made of medical information about you. To request this list or accounting of disclosures, you must submit your request in writing to the facility administrator. Your request must state a time-period that may not be longer than six years and may not include dates before April 14, 2003. Your request should indicate in what form you want the list (for example, on paper, electronically). The first list you request within a 12-month period will be free. For additional lists, we may charge you for the costs of providing the list. We will notify you of the cost involved and you may choose to withdraw or modify your request at that time before any costs are incurred.

Right to Request Restrictions - You have the right to request a restriction or limitation on the medical information we use or disclose about you for treatment, payment or health care operations. You also have the right to request a limit on the medical information we disclose about you to someone who is involved in your care or the payment for your care, like a family member or friend. For example, you could ask that we not use or disclose information about a surgery that

you had. *We are not required to agree to your request.* If we do agree, we will comply with your request unless the information is needed to provide you emergency treatment. To request restrictions, you must make your request in writing to the facility administrator. In your request, you must tell us (1) what information you want to limit; (2) whether you want to limit our use, disclosure or both; and (3) to whom you want the limits to apply, for example, disclosures to your spouse.

Right to Request Confidential Communications - You have the right to request that we communicate with you about medical matters in a certain way or at a certain location. For example, you can ask that we only contact you at work or by mail. To request confidential communications, you must make your request in writing to the facility administrator. We will not ask you the reason for your request. We will accommodate all reasonable requests. Your request must specify how or where you wish to be contacted.

Right to a Paper Copy of This Notice - You have the right to a paper copy of this notice. You may ask us to give you a copy of this notice at any time. Even if you have agreed to receive this notice electronically, you are still entitled to a paper copy of this notice. You may obtain a copy of this notice at our web site, <http://www.digestivehealth.net>. To obtain a paper copy of this notice, contact the facility administrator.

CHANGES TO THIS NOTICE We reserve the right to change this notice. We reserve the right to make the revised or changed notice effective for medical information we already have about you as well as any information we receive in the future. We will post a copy of the current notice in the office. The notice will contain on the first page, in the top right-hand corner, the effective date. In addition, each time you register at or are seen at the office for treatment or health care services as an outpatient, we will offer you a copy of the current notice in effect.

COMPLAINTS If you believe your privacy rights have been violated, you may file a complaint with the office or with the Secretary of the Department of Health and Human Services. To file a complaint with the office, contact Marianne Sloan, facility administrator. All complaints must be submitted in writing. You will not be penalized for filing a complaint.

OTHER USES OF MEDICAL INFORMATION Other uses and disclosures of medical information not covered by this notice or the laws that apply to us will be made only with your written permission. If you provide us permission to use or disclose medical information about you, you may revoke that permission, in writing, at any time. If you revoke your permission, we will no longer use or disclose medical information about you for the reasons covered by your written authorization. You understand that we are unable to take back any disclosures we have already made with your permission, and that we are required to retain our records of the care that we provided to you.

**CONSENT FOR RELEASE OF INFORMATION FOR TREATMENT,
PAYMENT AND HEALTH CARE OPERATIONS**

I, _____, hereby authorize Digestive Health Associates and the Southwest Endoscopy Center to use and/or disclose my health information which specifically identifies me or which can reasonably be used to identify me to carry out my treatment, payment and health care operations. I understand that Digestive Health Associates and the Southwest Endoscopy Center have reserved the right to change their privacy practices and that I can obtain such changed notice upon request. I understand that I have the right to request that Digestive Health Associates and the Southwest Endoscopy Center restrict how my individually identifiable health information is used and/or disclosed to carry out treatment, payment or health operations. I understand that Digestive Health Associates and the Southwest Endoscopy Center do not have to agree to such restrictions, but that once such restrictions are agreed to, Digestive Health Associates and the Southwest Endoscopy Center must adhere to such restrictions.

CONSENT FOR COLONOSCOPY

This document helps us inform you about this procedure. Please read it carefully and address any questions or concerns you may have personally with the doctor prior to signing it.

Dr. Patrick D. Gerstenberger, Dr. Steven R. Christensen, Dr. Stuart B. Saslow or Dr. Paula M. Dionisio, and his or her assistants are authorized to perform:

Colonoscopy - Examination of the large intestine, and often a portion of the lower small intestine, with a flexible tube passed through the anus.

Biopsy - Remove small pieces of tissue for analysis.

Polypectomy - Remove small growths with special instruments.

Treatment of hemorrhoids with infrared coagulation or band ligation - Treat internal hemorrhoids with an infrared light-heated probe or placement of small rubber bands internally.

Treatment of bleeding or abnormalities likely to cause bleeding - Use heat, metal clips, synthetic string-like loops, or rubber bands applied internally to stop or prevent bleeding.

Sedation and analgesia (moderate-deep procedural sedation with propofol) - Administer medication into a vein, under the doctor's direction, prior to and during the procedure, to make the procedure comfortable by relieving anxiety, discomfort, and pain.

Colonoscopy is frequently performed for the following reasons: screening and prevention of colon cancer, follow-up of prior polyps or cancer, evaluation of symptoms (such as bleeding/pain/diarrhea/constipation), evaluation of anemia, and evaluation or monitoring of inflammatory bowel disease.

ALTERNATIVES: Imaging tests (barium enema x-ray, CT, MRI or ultrasound) and a specialized form of CT scan (virtual colonoscopy) also provide information about the colon. Imaging tests are less likely to cause a procedural complication, but are less accurate for diagnosing some important conditions, and do not allow common treatments such as the removal of growths (polyps), which are removed in >1/3 colonoscopies performed by Digestive Health. No test at all is always an alternative, but no testing carries risks of failure to diagnose or prevent serious disease, such as colon cancer. In most cases we perform colonoscopy using moderate-deep propofol-based procedural sedation, under the endoscopy doctor's supervision. It is possible to perform this procedure in some cases without sedation. General anesthesia administered by an anesthesiologist is indicated in some cases, and is an alternative available at Mercy Regional Medical Center.

RISKS: These procedures involve some risks. To help you put these risks into perspective it is important to know that the average American has about a 1/17 risk for developing colon cancer, which is frequently fatal if detected in an advanced stage, but is usually preventable by colonoscopy. This risk is higher in individuals who have a family history of colon cancer or polyps. Major published reports of complications of colonoscopy include: **perforation** requiring surgery (up to 1/400), **bleeding** that potentially requires transfusion with its associated risks or surgery (up to 1/60 polyp removals), **diverticulitis** (1/3500), **heart or lung problems** (major problems are rare), infection (rare), damage to other internal organs or structures including injury to the spleen (rare), twisting of bowel causing blockage (rare), appendicitis (rare), allergic reactions (rare), nerve injury (rare), and death (rare). Minor complications (needle site irritation, internal burns or bruises, minor medication reactions, temporary bowel distention or prolonged sleepiness) occur infrequently. The treatment of hemorrhoids can lead to transient pain, bleeding, urinary symptoms and rare but potentially life-threatening problems with infections or blood clots.

At Digestive Health our perforation rate is <1/2000 and our rate of bleeding requiring hospital care is <1/450. Our endoscopic research consortium (www.cori.org) reported data describing the frequency of colonoscopy-related complications leading to hospitalization in May 2007. This study of over 18,000 colonoscopy procedures performed at multiple sites in the U.S. (over 1000 of these procedures were performed at the Southwest Endoscopy Center by Drs. Christensen, Gerstenberger and Saslow) reported admission for bleeding in 1/730 cases, perforation in 1/4600, diverticulitis in 1/3700, and postpolypectomy syndrome in 1/9,200. While perforations usually require surgery for repair, full recovery is typical. Colon cancers however, if not prevented, frequently present at an advanced state for which cure is not possible. These are highly accurate procedures, but with any medical test there is a small chance of missing something. **Not all cases of colon cancer are preventable with current techniques**, because not all colon cancers arise in growths that we are able to see with the colonoscope. Colonoscopy is the most effective available means for preventing colon cancer, and is estimated to prevent approximately 75% of cases if performed at recommended intervals by an experienced physician.

SEDATION: Sedation involves a risk of heart or lung problems (<1/200), which rarely (<1/160,000) can be fatal. Sedation (moderate-deep propofol procedural sedation) at this facility is administered and monitored by trained registered nurses under the continuous direction of the physician performing your procedure. While gastroenterology and endoscopy organizations in the U.S. support the use of propofol by gastroenterologists in the manner now employed at this facility for over 3 years, propofol sedation by gastroenterologists is not FDA approved. Anesthesia care provided by an anesthesiologist may be preferred to moderate-deep procedural sedation in some situations. Anesthesiologist services are not available at the Southwest Endoscopy Center but are available at Mercy Regional Medical Center and can be arranged at the request of either the patient or the physician performing your procedure, at an additional cost.

MEDICATIONS THAT AFFECT BLOOD CLOTTING: In most cases these drugs (such as Coumadin, Plavix, Effient, aspirin, nonsteroidal anti-inflammatory agents and others) are discontinued before colonoscopy to reduce possible bleeding risk related to polyp removal. Stopping and restarting these drugs carries some risk of blood clot related problems, including stroke and heart attack. In some cases we may advise you to continue these medications, in the belief that possible bleeding is less of a risk to your health than the risk of heart attack or stroke.

Complications may occur even when a procedure is properly performed. Treatment of major complications may require hospitalization, surgery (rarely including colostomy, a bag on the abdomen to collect waste), and blood transfusion.

RECUPERATION: Recuperation from colonoscopy is generally complete within a few hours following the procedure. Most individuals can return to typical activities and diet at that time. Because the effects of sedation on memory, coordination and judgment may linger however, activities such as driving, operation of machinery, vigorous physical exertion or activities requiring full mental attention, coordination or recall should not be resumed until the following day. **Increasing abdominal pain, bleeding, fever or other signs of illness could be signs of complication of colonoscopy or of your sedation, and should be reported promptly to the on call Digestive Health physician.** You will be provided with written instructions on discharge telling you how to contact us in the event of a problem after the procedure.

TRANSFUSION: Blood transfusions are not administered at the Southwest Endoscopy Center. Transfusions are occasionally necessary during the hospital management of colonoscopy-related bleeding.

SUCCESS: Complete examination of the colon (from the rectum to the cecum) is achieved in over 99% of Southwest Endoscopy patients. Most polyps we detect are removed at the time of the examination. Some large polyps or growths may require additional colonoscopy procedures or surgery to allow complete removal.

ASSISTANTS: Registered nurses and/or technicians who are employees of the facility providing your procedure will assist the physician. Students, industry representatives or other observers will not be permitted to be present without your written permission. Other physicians or assistants are rarely necessary during colonoscopy, though occasionally the physician may request an opinion regarding a finding or technique from another physician during a procedure.

PATIENT CONSENT

I have had sufficient opportunity to discuss my condition and treatment with my physicians and/or their associates, and all of my questions have been answered to my satisfaction. I believe that I have adequate knowledge upon which to base an informed consent to the proposed procedure.

I have read and fully understand this form and I voluntarily authorize and consent to this procedure. I understand that I should not sign this form until all my questions have been answered to my satisfaction and until I understand all the words or terms on this form.

I am aware that the practice of medicine is not an exact science, and I acknowledge that no guarantees have been made to me concerning the results of the procedure. I have been advised that the proposed procedure may not improve my condition and may, in fact, worsen it.

GENERAL PREPARATION FOR ENDOSCOPIC PROCEDURES

MEDICATIONS:

A. DO NOT STOP HEART AND BLOOD PRESSURE MEDICATION. Take your last dose at least 4 hours before your scheduled procedure with a few sips of water.

B. DO NOT STOP ASPIRIN, CLOPIDOGREL (PLAVIX®), PRASUGREL (EFFIENT®) OR COUMADIN WITHOUT SPECIFIC DIRECTION FROM OUR OFFICE TO DO SO. PLEASE INFORM US IF YOU TAKE THESE MEDICATIONS, AND THE REASON YOU DO.

You may take acetaminophen (Tylenol®) for minor aches and pains if needed.

B. YOU SHOULD AVOID THE FOLLOWING MEDICATIONS PRIOR TO YOUR PROCEDURE, as they may increase the risk of bleeding or cause other procedural difficulties.

7 days before your procedure, stop:

- **Ginko biloba**
- **St. John's Wort**
- **Olestra (Olean®)** - an artificial fat used in some snack foods such as potato chips, tortilla chips, cheese puffs, popcorn and crackers (Pringles® Light Original, and Pringles Light Sour Cream & Onion crisps, LAY'S Light Original Potato Chips, RUFFLES Light Cheddar and Sour Cream Flavored Potato Chips, RUFFLES Light Original Potato Chips and TOSTITOS Light Restaurant Style Tortilla Chips).

2 days before your procedure, stop:

- Nonprescription: **Ibuprofen (Motrin®, Advil®, Nuprin®, Medipren®), Naproxen (Aleve®), Ketoprofen (Orudis®)**
- Prescription Anti-inflammatory medications (examples include: **Anaprox®, Ansaïd®, Arthrotec®, butazolidin, Cataflam®, Clinoril®, Daypro®, Dolobid®, Feldene®, Indocin®, meloxicam, Motrin®, Naprelan®, Naprosyn®, naproxen, Oruvail®, Ponstel®, Relafen®, Toradol®, Trilisate®, Voltarin-XR®**).

CLEAR LIQUID DIET:

To qualify as a clear liquid, you must be able to see through the liquid (it may be colored, though avoid red or purple fluids). A clear liquid diet helps to clear the digestive tract of as much food residue as possible prior to your procedure.

Allowed foods:

- Clear fruit juices, e.g. apple, white grape.
- Gelatin (lemon, lime or orange; no fruit toppings)
- Popsicles (no sherbets or fruit bars)
- Fruit ices of the above fruit juices
- Black coffee (no milk or non-dairy creamers added)
- Black tea (no milk or non dairy creamers added)
- Carbonated beverages, e.g. Sprite®, Fresca®, ginger ale, cola
- Kool-aid®
- Soup: low-sodium chicken or beef bouillon / broth.
- Honey, sugar, hard candies.
- Gatorade® and similar sports drinks
- WATER!

Avoid large amounts of fluid colored red or purple.

PREAUTHORIZATION:

Please contact your insurance carrier in advance to verify your benefit and coverage levels. Digestive Health Associates will call to preauthorize your procedure, but you should call to verify your benefit and coverage levels. If you don't follow your policy's rules, it might not cover the expenses of your test with maximum benefit. Preauthorization is never a guarantee of coverage or payment.

COLON CLEANSE PREPARATION FOR COLONOSCOPY
With split dose oral electrolyte lavage

Please read these instructions at least three days before your scheduled colonoscopy.

You will be given a sedative for this procedure, and will not be able to drive until the following day. **YOU MUST ARRANGE IN ADVANCE FOR SOMEONE TO DRIVE YOU HOME.**

The purpose of the prep is to cleanse your colon. A clean colon is necessary for us to provide a safe, comfortable and accurate examination. **Failure to perform your colon cleanse properly could result in the doctor having to stop the procedure without completing it, leading to the additional costs and inconvenience of a repeat procedure.** Please don't hesitate to call us if you have any questions.

At least three days before your procedure: Pick up your prep kit prescription at your pharmacy.

Two days before your procedure: Begin avoiding foods containing seeds or fibrous skins (such as tomatoes, corn, lettuce, cucumbers, fruits). *If you normally have a bowel movement less frequently than once a day, take a full adult dose of Milk of Magnesia at bedtime (typically 4 TBSP of liquid form, or 8 chewable tablets).*

One day before your procedure:

In the morning, mix the prescription prep powder (Golytely®, Nulytely®, Colyte® or generic equivalent) into a solution as instructed on the bottle and refrigerate. Do not add flavoring unless the pharmacist has provided it as part of your prep kit (in which case it is optional). Otherwise, please follow the instructions on this page rather than the instructions enclosed with your prep kit.

Consume a regular diet (avoiding seeds and fibrous foods) until 6:00 PM. After 6:00 PM, you may not eat solid foods again until after your procedure is complete.

At 6:00 PM begin drinking the prep solution. Drink one 8-ounce glass every 10 minutes until you have finished **half** of the bottle (2 liters). You should be finished drinking by 8:00 p.m. You may drink clear liquids after 6 PM (see attached list).

You may feel bloated and nauseated as you drink. Some individuals may vomit. These side effects are temporary, and most individuals can successfully complete the prep. Within an hour or so of starting most individuals will begin having bowel movements that will progress to clear yellow diarrhea.

At 8:00 PM take two 5 mg tablets of bisacodyl (Dulcolax®).

The day of your examination: Four hours before your arrival time, take any necessary medication and begin drinking one 8-ounce glass of the remaining prep solution every 10 minutes, continuing until finished. You must finish the prep solution at least 2 hours before your arrival time.

Morning Procedures: Do not eat or drink anything after completing your prep.

Afternoon Procedures: You may continue to drink clear liquids up until 2 hours before your arrival time.

Final friendly reminders...

Our goal is to provide you with a safe, complete and accurate examination. For us to do this you must:

1. Arrange in advance for a ride home after sedation.
2. Limit your diet and cleanse your colon as instructed.
3. Remember not to eat or drink absolutely anything for **2 hours** prior to your procedure.
